	All consumer returns that PPN facilitates MUST have a completed PPN or Manufacturer product return form accompanied by the products UPC code and/or container as indicated. Returns that do not have the fully completed form and UPC/Container will be rejected.
	Credits for returned items may not be taken off PPN invoices without a credit authorization form.
	Credits submitted on manufacturer created forms that are rejected by the manufacturer will be charged back to the retailer.
